This service includes free copyright and UPC Codes and EAN Code 13-14-15 for your Distributions.

**REMIX:** is a service that allows you to promote and publish (no Distribution) on our Stark.TV Records platform on YouTube and Hearthis at a cost of € 5.00 (each) for your Remix.

**PROMOTE:** a service divided into two categories, Video & Facebook to expand your fame and advertise your content as Facebook pages and videos on your channel or on our dedicated platform. Stark.TV Records will provide you at no cost, a series of services including:

- Official artist area on our website
- Official Facebook page (dynamic and direct management by Stark.TV Records)
- Assistance 12 / 24h 6 / 7g.
- Dedicated Artist page for your listeners.
- Monthly statistics.
- Mastering service

In any other case regarding renewal, all copyrights and sales codes will be your property; the sales codes will be suspended, and will no longer be resold by external entities, in case of Distribution of a Single or Album in periods subsequent to the year of first publication, the sale will be achieved within 1–2 weeks (depends on the speed of the stores) payment will be required in reference to the type of service requested.
